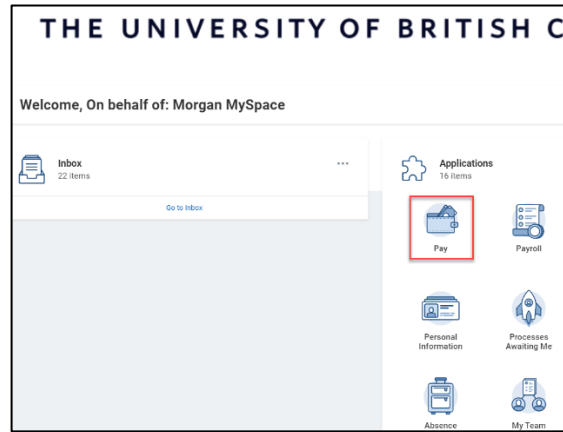

1. On Workday's home page, under **Applications** click the **Pay** worklet.

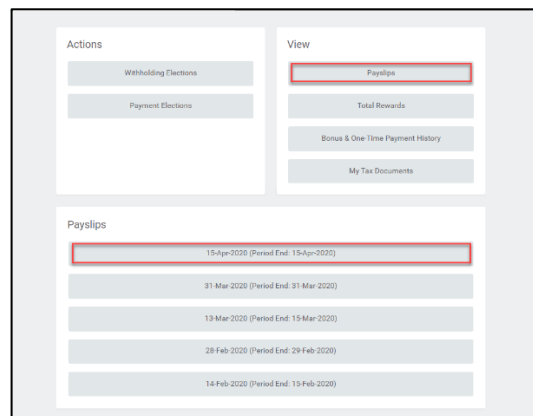


You now have 2 options.

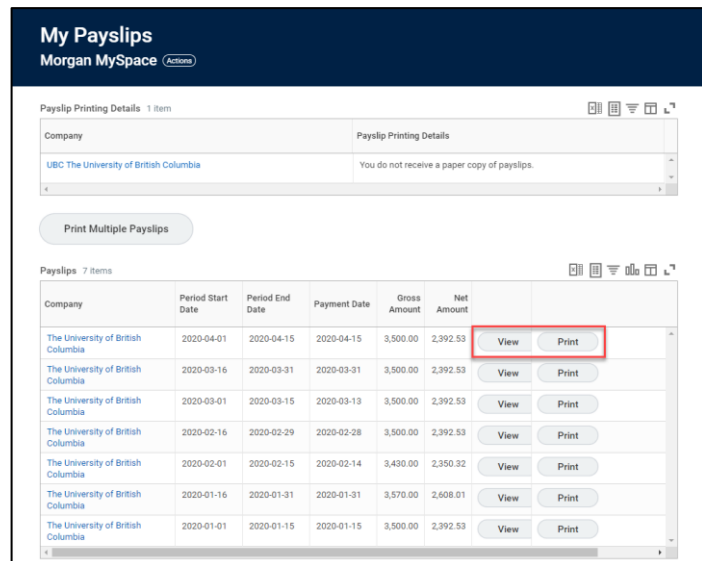
2. To **view a specific pay period:** in the **Payslips** section, click the pay period you wish to view.
